



PLAYERS' ELIGIBILITY

(How can a player qualify for the free spins, and who is eligible for the free spins?)

General Eligibility:

The Free Spins campaign is open to all of the client's end players who meet the following criteria:

- Players must have **one** valid registered account with the platform to participate.
- Players must engage in a **specified list of eligible slot games** during the campaign period.
- Eligible players who enter the specified slot games during the campaign period will **receive the free spins automatically** without needing to take any additional actions.

Distribution Methods:

Eligible players can receive Free Spins through two distinct distribution methods:

First-Come-First-Serve Basis:

- ✓ Free Spins are available to players on a first-come-first-serve basis, subject to campaign availability and conditions.
- ✓ Players who are first to partake in the campaign are automatically granted Free Spins upon entering the eligible slot games during the campaign period.

FREE SPINS SPECIFICATION

(How? How is this system designed?)

Campaign Flow

The Free Spins Campaign features a tri-wallet system on the game-client interface, comprising the Cash Wallet, Bonus Wallet, and Free Spins Wallet.

When players are credited with free spins, these are deposited into their **Free Spins** Wallet, where they are available for use. Winnings accrued from these spins are then transferred to the **Bonus Wallet** and are contingent upon the completion of a **Turnover Requirement**.

Upon satisfying the turnover criteria within the **Bonus Wallet**, the system will automatically transfer the winnings — up to a predetermined maximum amount — to the player's **Cash Wallet**.

It is important to note that players have the flexibility to navigate between these wallets during their gaming sessions.

However, the wagering requirements for any winnings can only be met within the Bonus Wallet; the Cash Wallet remains distinct and separate to fulfil turnover obligations.

Built-In Promo System

Cash Wallet

The Cash Wallet serves as the primary wallet for gameplay.

The balance in the Cash Wallet is withdrawable.

Bonus Wallet

The Bonus Wallet functions as the designated wallet for players to fulfill the turnover requirement for the winning amount from the Free Spins Wallet.

Players must meet the turnover requirement to withdraw the **winning amount** within the specified range of minimum and maximum withdrawal amounts. If no turnover requirement is necessary from Free Spins, the winning amount from Free Spins within minimum and maximum withdrawal range will go directly to the Cash Wallet.

The winning amount will be transferred from the Bonus Wallet to the Cash Wallet through the 'CPSettle' API.


Free Spins Wallet


Free Spin Wallet is where players receive Free Spins. Players must use up all the Free Spins before they can proceed to fulfill the turnover requirement in the Bonus Wallet or withdraw winnings to the Cash Wallet within the specified minimum and maximum withdrawal amounts.




Detailed Flow 1


When a player is eligible for the free spins, a pop-up message will appear during gameplay.









After all free spins have been utilized, the final winning will be transferred to the **BONUS WALLET** for turnover requirement fulfillment.












Detailed Flow 1







Upon fulfilling the turnover requirement, the balance up to the specified maximum limit will automatically be transferred to the CASH WALLET.










Detailed Flow 2


When a player is eligible for the free spins, a pop-up message will appear during gameplay.








Once all free spins have been utilized and the winnings in the Free Spin Wallet fall **below the minimum stake**, players are deemed to have **failed** as they cannot proceed with fulfilling the turnover requirement in the Bonus Wallet.









FREE SPINS SAMPLE COMPUTATION

Free Spins Value: 0.25 MYR

Total Free Spins Allocated: 10

Final Winning Amount from the Free Spins: 20 MYR

Turnover Required: 20 MYR, with 1x turnover

Minimum Withdrawal: 1 MYR

Throughout the campaign, players will receive **10 Free Spins**, each valued at **0.25 MYR**, credited to their Free Spins Wallet. Once all 10 allocated free spins have been utilized, the resultant winnings, up to **20 MYR**, will be moved to the Bonus Wallet to satisfy the turnover requirements.

Players must achieve a turnover of 20 MYR within the Bonus Wallet to be eligible for withdrawal. Should the bonus balance surpass the maximum withdrawal threshold after completing the turnover requirement, any remaining funds will be forfeited.

Example:

Maximum Withdrawal limit = 10 MYR

After fulfilling the turnover requirement, the player's Bonus Wallet balance is **30 MYR**, but only **10 MYR** will be transferred to their **Cash Wallet**, and the system will **deduct** the remaining amount.



TERMS & CONDITIONS

- 1. The Free Spins campaign is available to eligible players on a first-come-first-serve basis.
- 2. No deposit is required to redeem this Free Spins.
- 3. Players will be granted 10 free spins with 1 IDR (000) value each during the campaign period.
- 4. Free Spins are accessible in AdvantPlay's Free Spins wallet when the player enters AdvantPlay game during the campaign period.
- 5. AdvantPlay will issue a total of 10,000 Free Spins throughout the campaign period.
- 6. Qualified Games include ALL games except for accumulative games, such as *Fantastic Beast* and *Crazy Bounty*.
- 7. Players may start betting upon entering our games via the Free Spins wallet.
- 8. Only wagers placed via the Bonus Wallet will contribute towards the turnover requirement.

 Wagers made via the Cash Wallet are excluded from the wagering requirement.
- 9. There is no minimum stake required for these free spins.
- 10. Winnings from free spins require a 1x turnover to be completed in the Bonus Wallet. After meeting the wagering requirements, the eligible withdrawal balance will be automatically transferred to the Cash Wallet (subject to a maximum amount cap).
- 11. Players can perform withdrawals anytime once the withdrawable amount is in the Cash Wallet.
- 12. In the event of invalid tickets caused by AdvantPlay, refunds will be issued to the player's Bonus Wallet, and the affected ticket's turnover/win-loss will be considered null (counted as 0).
- 13. The minimum and maximum withdrawal for a player from the Free Spin is 1 IDR (000) 33 IDR (000).
- 14. Any balance exceeding the maximum withdrawal amount will be cleared upon the completion of the turnover requirement (e.g., the balance after completing a 1x turnover in the Bonus Wallet).
- 15. Players are allowed to use only **ONE** valid registered account with the platform. Any attempt to manipulate or abuse the campaign, including creating multiple accounts or using automated systems, may result in disqualification and forfeiture of winnings.
- 16. AdvantPlay reserves the right to modify the terms and conditions of this campaign at any time.
- 17. All decisions made by AdvantPlay regarding this campaign are final.
